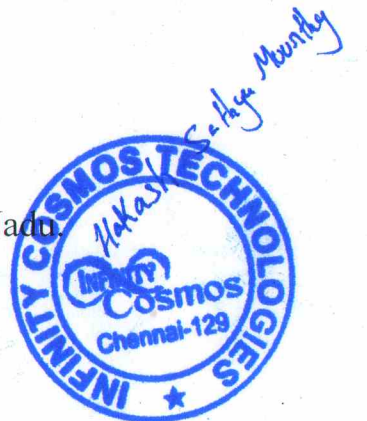

1.5 The Second Party will actively engage to help with the delivery of training and assist in providing Technical workshop seminar and internships for the First Party's students.

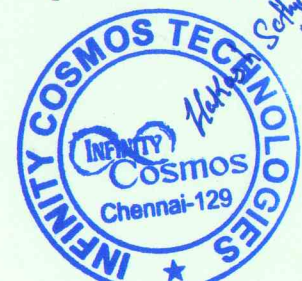
5. MISCELLANEOUS
